

FXCC Refer a Friend Program

Terms & Conditions 2019

FXCC (the “Company”) is running the “Refer-a-Friend” Program (the “Program”). By registering to become a Referrer and by participating in the Program, you agree to the Terms and Conditions set out below.

1. This program is exclusive for the Company’s Clients who do not reside in the European Union.
2. To qualify for the Program and receive a reward for referring a Friend, the Referrer must have a verified real account with the Company.
3. Any Friend referred to the Company under the Program, by the Referrer must not be an existing client of the Company.
4. The Referrer will be granted eligibility to receive the Refer a Friend reward when all of the following conditions are met:
 - a) The referred Friend has registered using the tracking link provided by FXCC via email in order to establish the referral connection
 - b) The referred Friend has opened a real account with FXCC
 - c) The referred Friend has deposited funds into his/her Live trading account
 - d) The referred Friends’ initial deposit is not less than \$100 for the ECN XL account type.
 - e) The referred Friend has completed the required number of lots based on his/her initial deposit
5. Friend will be granted eligibility to receive a reward once the required volume is met, based on the initial deposit made.
6. This reward is based on the initial deposit and cannot be applied to the subsequent deposits made by the referred Friend.
7. In case that the Friend has not completed the requirement of first deposit within 1 month of registration, the reward can no longer be applied.
8. In case that the Friend performs a withdrawal of the initial deposit prior to the calculation date, the reward will not be paid to the Referred and the Friend.
9. This reward cannot be combined with any other promotional campaign that FXCC will offer.
10. the Referrer confirms that Friends who are receiving the Referrer link for the purposes of this Program:
 - a) Do not reside in the European Union
 - b) Are older than 18 years old
 - c) Consent to receive the Referrer link
11. The Referrer must not promote themselves as an agent, IB or Affiliate of FXCC.
12. The Referrer cannot use the program to refer themselves.
13. The Friend must be referred only by the Referrer and not associated with any referring party.
14. There is no limit imposed on the number of Friends that may be referred to FXCC.

15. The reward amount shall be credited into the Referrers and Friends trading account on the 15th of each calendar month, provided that the Friend has met the minimum requirements.
16. If the Company suspects that a Friend has abused or attempted to abuse the Program, the Company reserves the right to deny or withhold the reward without Referrer’s and/or Friend’s consent.
17. It is understood that any inappropriate use of the Referrer Link may cause immediate termination of the Referrers participation in the Program.
18. Whereas the Friend has communicated to the Company that he/she wishes to be removed and/or unlinked from a Referrer, FXCC shall remove the Friend accordingly and the Referrer shall have no rights in respect of the unlinked Friend. Under no circumstances shall FXCC be liable for any consequences of any such removal from a Referrer.
19. FXCC reserves the right to remove the reward without any prior notice, at its sole discretion. The decision shall be final and binding.
20. FXCC reserves the right, as it in its sole discretion deems fit, to alter, amend, extend, suspend, cancel or terminate the Refer-a-Friend Program, or any aspect of the Program, at any time and without any prior notice. Under no circumstances shall FXCC be liable for any consequences of any alteration, amendment, suspension, cancelation or termination of the Program.

Refer-a-Friend Reward Structure

Below is the Company’s reward structure for Referrals and the Friends introduced, which is based on the following deposit amounts and minimum traded volumes:
